## 11. Terms and Condition for NOC:

- (i) The Organizer will be held responsible for any violation of provisions of Protection & Maintenance Ordinance of Quaid-i-Azam Mausoleum.
- (ii) The program is allowed for \_\_\_\_\_\_ only and subject to clearance of security agencies.
- (ii) Any damage to the Mazar property a grill boundary wall will have to be made good by the Organizer at his expense without any excuse etc.
- (iv) The Organizer will be responsible for coordination with the concerned police authorities (Traffic & Area police) for law and order and other traffic problems.
- (v) The Organizer will make their own arrangement regarding electricity connection from Ms. K-Electric Authorities:
- (vi) The Organizer will ensure that no public movement is disturbed during the time of event.
- (vii) The Organizer will not destroy, damage, alter, injure, deface or mutilate the Quaid-i-Azam's Mazar or any part there or scribble, write, or engrave any inscription or sign on any part of the Mazar.
- (viii) The NOC will automatically stand cancelled in case of breach of any of the above condition.

## 12. Procedure for Grant of NOC:

- (b) The Organizers will submitted duly filled application form to the QMMB office at lest 10 days before the date of scheduled event.
- (c) Duly filled application form alongwith letter will be forwarded to competent authority. i. e Secretary National Heritage & Culture Division atleast 07 days before the scheduled event for approval.
- (d) On grant of the approval, RE will issue the NOC for the Program / event.
- (e) The competent Authority reserves the right to reject any proposal for organizing any event at Mazar-e-Quaid without assigning any reason.
