BOARD RULES 1969

AMENDMENT IN 1991

QUAID-I-AZAM'S MAZAR'S MANAGEMENT RULE.

These rules shall be called "Quaid-i-Azam's Mazar Management Board Rules 1969 amended in 1991".

- 2. They shall be deemed to have come into force with immediate effect.
- 3. They shall apply to all officers and staff other than the officers and staff on deputation from the Federal or a Provincial Government, whether borne on regular, contingent or work-charged establishment or whether working whole-time, part-time for salary / wages, for Honorarium or in any honorary capacity.
- 4. The officer and staff on deputation from the Federal or a Provincial Government shall be governed by the rules of their respective Government and the terms and conditions of their deputation.
- 5 The over all control of the fund shall vest in the QMM Board.
- 6. The Quaid-i-Azam's Mazar Management Board shall be the competent authority to add modify or rescind any of these rules.
- 7. Except as provided in these rules specifically, the provision of the following rules as amended from time to time shall apply to the officers and staff referred to in rule 3 above.
 - (1) Government Servants (Efficiency & Discipline) Rules.
 - (2) Civil Services (Classification, Control and Appeal) Rules.
 - (3) Government Servants Conduct Rules.
 - (4) General Financial Rules.

In addition, such instruction, general or special, issued by the Government of Pakistan from time to time in respect of their employees as may be adopted by the Board shall also be applicable to these officers and staff.

- 8. The rules for the construction of the Quaid-i-Azam Mausoleum, its allied buildings and its peripheral area Karachi given in the annexure to these rules shall be followed for all works undertaken and executed under the Fund, the provision as of the following codes and rules shall apply in all matters not covered by the rules in the annexure:-
 - (1) Central Public Works Account Code.
 - (2) Central Public Works Department Code.
 - (3) General Financial Rule.
 - (4) Central Treasury Rules.
- The Board shall have power to modify any of the provisions of the rules and codes referred to in rules 7 and 8 to the extent considered necessary for the special circumstances of the Fund. If the date from which the modification is to take effect is not specified in the orders of modifications, the modification shall take effect from the date of issue of the orders.
- 10. The QMM Board shall have the same powers and function as Government in the rules and codes referred to in rules 7 & 8.
- 11. The Honorary Secretary of the Board shall have the same powers and functions as Heads of Departments in the rules and codes referred to in rules 7 & 8.
- 12. The Honorary Treasurer of the Fund shall have custody of all moneys in the Fund, shall make all disbursements and keep accounts and shall carry out annual or special audit of the expenditure incurred from the Fund. The Honorary Treasurer may delegate such of his functions and powers, as he may consider necessary to an officer working under him.
